Purpose of the RCCDF Portal

Provide participating countries and regional stakeholders with:

- 1. **Discoverability:** the ability to identify and understand what data, information and knowledge already exists.
- 2. Accessibility: the ability to access relevant data, information and knowledge where appropriate.
- 3. Sharing options: the ability to share data, information and knowledge among other participating countries.
- 4. Utilisation guidance: the ability to more easily understand how to utilise projections data and undertake adaptation planning.















Current RCCDF Stocktake

The RETA team is currently undertaking a stocktake of what climate change data and information exists. Not yet started in Thailand, but will involve:

- 1. **Identifying priority content:** Determining the key discipline areas and content types required.
- 2. Identifying custodians: Identifying the key sources for discovering and accessing priority content.
- 3. Standardised metadata descriptions: The process of determining a vocabulary of terms for describing climate change data in the region.
- 4. **Content Inventory:** Developing and populating an inventory of priority content.

Current status of KM for Climate Change in Thailand

- □ In Thailand, KM is a key element at least in:
 - national response to CC issue,
 - better awareness and understanding of CC and its effects,
 - engagement of all stakeholders in CC-related policies/actions,
 - Bridging communication gap between researchers/policy makers.
- Thailand recognized its importance and implements through the Article 6 activities/programmes of UNFCCC (Education, Training and Public awareness).
- Easy-access platform to CC data/information is a common mechanism of KM, and some governmental agencies/NGOs provide such a service to specific stakeholders.
- However, national CC data/information portal has not been established yet.

Future improvements needed

- Prioritized areas of national CC data/information management need to improve in order to participate RCC portal initiative:
 - Awareness of good data management practices/process
 - Data sharing among stakeholders (Government/NGOs and external/internal sources)
 - Capacity in data and information management
 - Bridging the gap between scientific and technical assessments into policy.
- Data/information providers, management systems and user requirements should be taken into account to improve national CC data/information portal.
- Mechanisms to ensure sustainability of the national CC portal should be established.
